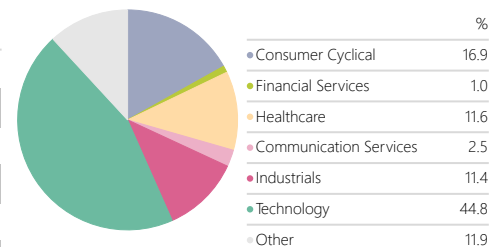

The Fund is rated for the 3 year time period among 291 funds in the category, the 5 year time period among 280 funds in the category and the 10 year time period among 216 funds in the category.
